4. Pre-bid meeting shall be held at Budhinanda Municipality, Bajura at May 29, 2019 (Jestha 15, 2076) at 14:00 hrs.
5. Sealed bids must be submitted to the office of Budhinanda Municipality, Bajura before June 14, 2019 (Jestha 31, 2076) at 12:00 hours. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at June 14, 2019 (Jestha 31, 2076) at 14:00 hours at the office of Budhinanda Municipality, Bajura. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security. Which bid security shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.

In case of discrepancy or error in Tender notice, bid document and other document of construction of various roads upgrading mentioned above municipality reserves right to amend, correct at any time.
