1. Budhinanda Municipality has allocated funds or received a grant from Nepal government towards the cost of below table works and intends to apply part of the funds to cover eligible payments under the Contract for road maintenance, water supply. Bidding is open to all eligible Nepalese and Foreign Bidders.
2. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years and enlisted by DoLIDAR are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLIDAR may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

4. A complete set of Bidding Documents may be purchased from the office of Budhinanda Municipality, Bajura and by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, firm renew, Vat registration, tax clearance, Original Power of attorney, Notary and upon payment of a non-refundable fee till May 29, 2019 (Jestha 15, 2076) up to office hour.

5. Pre-bid meeting shall be held at Budhinanda Municipality, Bajura at May 21, 2019 (Jestha 7, 2076) at 14:00 hrs.
6. Sealed bids must be submitted to the office of Budhinanda Municipality, Bajura before May 30, 2019 (Jestha 16, 2076) at 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at May 30, 2019 (Jestha 16, 2076) at 14:00 hours at the office of Budhinanda Municipality, Bajura. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security. Which bid security shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
10. In case of discrepancy or error in Tender notice, bid document and other document of construction of various roads upgrading mentioned above municipality reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Budhinanda Municipality, Kolti, Bajura
11. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
